The charity has no paid staff, who are close members of the family of the Executive Head or Board members, who each receives total remuneration of more than \$50,000 during the year.

MANAGEMENT OF CONFLICT OF INTEREST

RiverLife Community Services Ltd

A conflict of interest arises whenever the personal or professional interests of a person may potentially interfere with the performance of his/her duties and responsibilities to the organization he/she serves in or may affect his/her objectively in decision-making.

When actual, potential or perceived conflict of interest arises, the integrity, fairness and accountability, RCS hereby endeavors to do the following:-

- a. Establish clear and written conflict of interest policies;
- b. Establish disclosure as a normal practices;
- c. Exhort all Directors, Members, staff and volunteers ("volunteer" includes anyone serving RCS in any capacity who is not a Director, Member or staff of RCS) to lead by example an attitude and act of personal integrity.

A member of the Charity who is in any way, directly or indirectly, interested in an transaction or project or other matters of the Charity shall disclose the nature of his/her interest at the first meeting of the Charity at which he/she is present after the relevant facts have come to his/her knowledge.

A disclosure shall be recorded in the minutes of meeting of the Charity and, after the disclosure, that member:

- a. Shall not take part in any deliberation or decision of the Charity with respect to that transaction or project;
- b. Shall be disregarded for the purpose of constituting a quorum of the Charity for such deliberation or decision.

The youths undergo outdoor challenges together with dedicated youth mentors that guide them. Through both platforms, youth in the Generation 412 can develop holistically.

ACES TUITION

The ACES Programme in RCS seeks to empower children aged 5 to 12 years from low-income families with academic coaching to reach greater potentials in their Pre-school and Primary School journey. With 1-1 academic coaching, the student can gain mastery over their academics and have an increased school preparedness.

The Casework and Counselling services complement other programmes in helping to provide holistic assistance for the family, youth or children in their related struggles.
